Rex Minerals Ltd (“Rex”) advises that 1,810,000 fully paid ordinary shares have been issued for consideration of exploration contract drilling and related services for the period ending 30 September 2008.

On 23 July 2007, the Company entered into an agreement with Titeline Drilling Pty Ltd (“Titeline”) pursuant to which Titeline has agreed to provide the Company with certain drilling and related services. The services will be provided for a period of 672 days of drilling. The services are to comprise all activities and costs associated with diamond and percussion drilling.


Rex also advises that due to the resignation of employees, 120,000 unlisted options at an exercise price of \$0.365, originally expiring 30 June 2011, have now lapsed.
