North Creswick (EL4920) transfer completed

Rex Minerals Limited (Rex) is pleased to announce it has completed the transfer of EL4920 from Lihir Australia Holdings Pty Ltd (Lihir), via its subsidiary Ballarat West Goldfields Pty Ltd, into Rex Minerals (Victoria) Limited, a wholly owned subsidiary of Rex.

EL4920 covers the entire project area known as North Creswick, which has an historical production of 1.7 million ounces of gold. Details about the North Creswick project can be found on Rex's website www.rexminerals.com.au and in Rex's prospectus which was issued in August 2007.

The transfer of EL4920 completes the agreement between Rex and Lihir, which includes the issue of 1 million fully paid shares as consideration to Lihir for the purchase of EL4920. Lihir maintains a 2% royalty interest in EL4920. The Appendix 3B follows accordingly.
